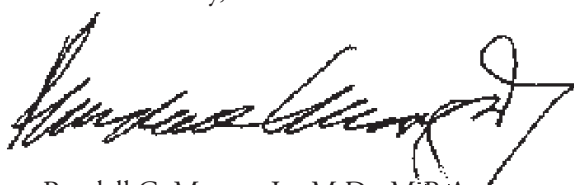

Montague Cobb Reception is held in their honor during the evening of the W. Montague Cobb Scientific Symposium and Lectureship at the NMA Convention.

2026 W. Montague Cobb Lifetime Achievement Award

Georges C. Benjamin, M.D.

CEO

American Public Health Association (APHA)

We are honored to present the 2026 W. Montague Cobb Lifetime Achievement Award to Dr. Georges C. Benjamin in recognition of a distinguished career dedicated to advancing public health, promoting health equity, and improving the health and well-being of communities across the nation.



For more than four decades, Dr. Benjamin has been one of the most respected and influential physician leaders in American public health. Since 2002, he has served as Executive Director of the American Public Health Association (APHA), the nation's oldest and largest public health organization. Under his leadership, APHA has championed prevention, health equity, emergency preparedness, and evidence-based public policy while elevating the national dialogue on the social and structural factors that shape health outcomes.

Prior to joining APHA, Dr. Benjamin served as Secretary of the Maryland Department of Health and Mental Hygiene after serving as the state's Deputy Secretary for Public Health Services. Throughout his career, he has held leadership roles spanning military medicine, emergency medicine, hospital administration, public health practice, and health policy. His unique ability to bridge clinical medicine and population health has made him a trusted voice during some of the nation's most consequential public health challenges.

Dr. Benjamin earned his undergraduate degree from the Illinois Institute of Technology and his medical degree from the University of Illinois College of Medicine. He completed residency training in internal medicine at Brooke Army Medical Center and went on to serve in a variety of leadership positions within military and civilian healthcare systems. A board-certified internist, he is a Master of the American College of Physicians, a Fellow of the National Academy of Public Administration, an honorary Fellow of the Royal Society of Public Health, and a member of the National Academy of Medicine.

An accomplished scholar and communicator, Dr. Benjamin has authored more than 200 scientific publications, book chapters, and policy commentaries. His work has influenced generations of public health professionals and informed national conversations on prevention, health disparities, healthcare access, and public health infrastructure. Widely recognized for his leadership, he has repeatedly been named among the most influential individuals in healthcare and health policy in the United States.

Named for Dr. W. Montague Cobb—physician, scientist, educator, and civil rights advocate—this award honors individuals whose careers exemplify sustained excellence, leadership, and service. Dr. Benjamin's lifelong commitment to advancing health equity, strengthening public health systems, and improving the lives of underserved populations embodies the spirit and legacy of Dr. Cobb.

By honoring Dr. Benjamin with the 2026 W. Montague Cobb Lifetime Achievement Award, we celebrate a visionary physician, public health leader, and advocate whose impact will continue to shape medicine and public health.

About the W. Montague Cobb Lifetime Achievement Award

Named for William Montague Cobb, M.D., Ph.D. (1904–1990), Physical Anthropologist, Anatomist, Activist, and Prolific Writer.

History: Dr. Cobb dedicated his life to promoting civil rights and combating segregation and discrimination in medical education and healthcare. To honor his contributions, the W. Montague Cobb Lifetime Achievement Award was established in 2006.

General Criteria for the Award: Recognizes individuals with over 20 years of consistent contributions in the field of medicine.

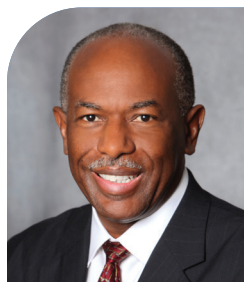

An internationally recognized physician-scientist, Dr. Hildreth has devoted his career to expanding scientific knowledge while ensuring that research serves the needs of communities disproportionately affected by disease. His pioneering investigations into HIV biology transformed understanding of viral infection and identified the critical role of cholesterol in HIV entry and replication. These discoveries generated multiple patents and contributed to translational advances that ultimately informed FDA-approved therapies.

Dr. Hildreth's distinguished academic journey began at Harvard University, where he earned a Bachelor of Arts degree before being awarded a Rhodes Scholarship to the University of Oxford, where he earned a doctorate in immunology. He subsequently earned his Doctor of Medicine degree from the Johns Hopkins University School of Medicine and remained at Johns Hopkins for more than two decades as a student, researcher, professor, and academic leader.

Throughout his career, Dr. Hildreth has combined scientific excellence with a commitment to mentorship and institutional transformation. As Dean of the College of Biological Sciences at the University of

California, Davis, he expanded interdisciplinary research initiatives and pioneered innovative educational programs that enhanced student success and scientific collaboration. Since becoming President and CEO of Meharry Medical College, he has led the continued growth of one of the nation's premier historically Black academic health science centers, strengthening its research enterprise, expanding strategic partnerships, and advancing its mission to improve the health of underserved communities.

Beyond his scientific accomplishments, Dr. Hildreth emerged as one of the nation's most trusted voices during the COVID-19 pandemic, helping translate complex scientific concepts into accessible public guidance. His service has included appointments to the FDA Vaccines and Related Biological Products Advisory Committee, President Biden's Health Equity Task Force, and numerous national scientific and advisory boards. He is a member of the National Academy of Medicine and has received widespread recognition for his leadership, mentorship, and contributions to science and society.

Named for Sir Cato T. Laurencin, MD, PhD, KCSL—surgeon, engineer, scientist, inventor, and internationally renowned research leader—this award recognizes individuals whose careers have advanced scientific discovery while addressing society's most pressing health challenges. Dr. Hildreth's career exemplifies these ideals through groundbreaking research, transformative leadership, and an unwavering commitment to developing future generations of scientists and physicians.

By honoring Dr. Hildreth with the 2026 Cato T. Laurencin Lifetime Research Award, we celebrate a physician-scientist whose contributions have advanced biomedical knowledge, strengthened academic medicine, and expanded opportunities for countless students, trainees, and researchers.

Georges C. Benjamin, M.D. is CEO of the American Public Health Association (APHA), where he has served since 2002, leading national efforts to advance public health, health equity, and prevention. A nationally recognized physician leader, Dr. Benjamin previously served as Secretary of the Maryland Department of

Health and Mental Hygiene and held senior public health leadership roles in the District of Columbia and the U.S. Army Medical Corps. He is a member of the National Academy of Medicine and the author of more than 200 scientific articles and book chapters. Dr. Benjamin served as co-chair and editor of *Unequal Treatment Revisited: The Current State of Racial and Ethnic Disparities in Health Care*, helping shape the national dialogue on racism, health equity, and systems change. A board-certified internist, Dr. Benjamin

earned his medical degree from the University of Illinois College of Medicine and trained in internal medicine at Brooke Army Medical Center. He is a Master of the American College of Physicians, a member of the National Academy of Medicine, a fellow of the National Academy of Public Administration, and an honorary fellow of both the Faculty of Public Health and the Royal Society of Public Health. Laurencin, M.D., Ph.D., KCSL is University Professor at the University of Connecticut, where he serves as the Albert and Wilda Van Dusen Distinguished Professor of Orthopaedic Surgery, Professor of Chemical and Biomolecular Engineering, Professor of Materials Science and Engineering, Professor of Biomedical Engineering, and Chief Executive Officer of The Cato T. Laurencin Institute for Regenerative Engineering. An internationally renowned physician-scientist, engineer,

and academic leader, Dr. Laurencin is a pioneer in regenerative engineering and a nationally recognized leader in advancing health equity and addressing racial and ethnic health disparities. He co-founded the W. Montague Cobb/NMA Health Institute and has been a longstanding advocate for equity in medicine and science. Dr. Laurencin earned his BSE in Chemical Engineering from Princeton University, his MD from Harvard Medical School, and his PhD in Biochemical Engineering/Biotechnology from the Massachusetts Institute of Technology. He is the recipient of the National Medal of Technology and Innovation and is the first surgeon elected to the National Academy of Sciences, National Academy of Engineering, National Academy of Medicine, and National Academy of Inventors. Dr. Laurencin is Principal Investigator of the RWJF-supported national initiative, “Exploring Multifaceted Solutions That Can Increase and Support Black Representation in Science, Engineering, and Medicine,” under which this symposium is convened.

Joan Y. Reede, M.D., M.S., M.P.H., M.B.A. is Dean for Culture and Community Engagement at Harvard Medical School and one of the nation’s most influential leaders in advancing equity, diversity, and inclusion in academic medicine and the health professions. A pediatrician, psychiatrist, educator, and policy leader, Dr. Reede has created more than 20 programs at Harvard Medical School focused on expanding pathways into medicine, biomedical research, and health leadership for historically underrepresented populations. Her national leadership has included service on numerous advisory bodies, including the U.S. Department of Health and Human Services Advisory Committee on Minority Health, the NIH Advisory Committee to the Director, and the Association of American Medical Colleges Board of Directors. Dr. Reede earned her undergraduate degree from Brown University, her medical degree from the Mount Sinai School of Medicine, completed residency training at Johns Hopkins Hospital and fellowship training at Boston Children’s Hospital, and holds graduate degrees from Harvard and Boston University. She is a member of the National Academy of Medicine, a Fellow of the American Association for the Advancement of Science. She is the 2024 recipient of the W. Montague Cobb Lifetime Achievement Award.

Paris “AJ” Adkins-Jackson, Ph.D., M.P.H. is a multidisciplinary, community-partnered health equity researcher and Assistant Professor of Epidemiology and Sociomedical Sciences at Columbia University Mailman School of Public Health. Her research examines how structural racism shapes health across the life course, with particular focus on healthy aging among historically marginalized communities, including Black and Pacific Islander populations. Her work explores the effects of adverse community-level exposures—including policing, segregation, and structural inequities—on psychological well-being, cognitive function, and biological aging, while also advancing anti-racist, community-engaged interventions to strengthen institutional trust and improve health outcomes. She is widely recognized for her scholarship on measuring structural racism in public health research and academic medicine and serves on the board of the Society for the Analysis of African American Public Health Issues. Dr. Adkins-Jackson earned a B.A. from Humboldt State University, an M.A. from the California Institute of Integral Studies, an M.P.H. from Claremont Graduate University, and a Ph.D. from Morgan State University.

Griffith, Ph.D. is the Risa Lavizzo-Mourey Population Health and Health Equity University Professor at the University of Pennsylvania, where he is Professor of Family and Community Health in Penn Nursing and Professor of Medical Ethics and Health Policy in the Perelman School of Medicine. A public health psychologist trained in psychology, community-based participatory research, and health disparities, Dr. Griffith’s work focuses on advancing anti-racism approaches to achieve racial, ethnic, and gender equity in health. His research has been particularly influential in centering the experiences of Black men to inform population health, chronic disease prevention, and intersectional health policy. Dr. Griffith is Director of the Program for Research on Men’s Health, Fellow and Senior Advisor on Health Equity and Anti-Racism in the Leonard Davis Institute of Health Economics, and Editor-in-Chief of the International Journal of Men’s Social & Community Health. He earned his B.A. from the University of Maryland, his Ph.D. in Clinical-Community Psychology from DePaul University, and completed postdoctoral training in community-based participatory health disparities research at the University of North Carolina at Chapel Hill.

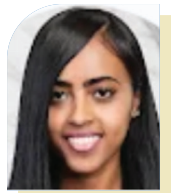

Scientific Contributions and Institutional Highlights

In 2026, the W. Montague Cobb Institute celebrates 22 years of research and focus upon the elimination of racial and ethnic health disparities in health and healthcare in the U.S.

SCIENTIFIC CONTRIBUTION

Across its 2025 volume, the *Journal of Racial and Ethnic Health Disparities (JREHD)* published 363 substantive articles, excluding corrections, reflecting both the breadth and depth of scholarship in the field. This included 321 empirical studies, 38 evidence-synthesis articles, and 4 perspectives, collectively underscoring *JREHD*'s interdisciplinary contributions to understanding and addressing racial and ethnic health disparities.

Key advances emerged in genomics, epigenomics, and computational research. Kolpakov et al. examined genome-related mechanisms contributing to racial differences in Alzheimer's disease incidence, while Ruiz-Narváez et al. explored perceived racism, genome-wide DNA methylation, and epigenetic aging in the Black Women's Health Study. Criss et al. analyzed ChatGPT-generated HIV advice, Fatemi et al. and Prochnow et al. used network analysis to examine maternal and chronic disease disparities, and Brown et al. investigated algorithmic fairness in low-birthweight predictive models.

Several articles strengthened the evidence base for equity-focused action. Ross et al. highlighted culturally responsive strategies for NIH trial recruitment, while Kader et al. examined community-informed approaches to disaggregated race and ethnicity data collection in health care settings. Rattan et al. contributed evidence on patient-provider racial concordance and postpartum care, and Zubizarreta et al., Bell et al., and Fraiman et al. advanced structural racism research through policy analysis, conceptual frameworks, and the development of the Healthcare Racial Justice Assessment Tool.

The volume also examined inequities in clinical care, quality, and treatment across multiple disease areas and care settings, including ALS diagnosis and prognosis (Raymond et al.), regional anesthesia (Powell et al.), non-elective cesarean delivery (Kausar et al.), and total knee arthroplasty outcomes (Balachandran et al.).

JREHD continues to demonstrate strong growth and scholarly impact. In 2025, the journal recorded 1.2 million downloads and maintained strong citation performance, including a Scopus CiteScore of 7.5 and a Journal Impact Factor of 2.2, as reported on the SpringerLink journal homepage. It also ranks in the top tier of Scopus-indexed Anthropology journals and supports timely dissemination, with a median 5 days to first decision. In 2025, Editor-in-Chief Sir Cato T. Laurencin, M.D., Ph.D., K.C.S.L. received the Springer Nature Editor of Distinction Award in recognition of the quality, volume, and efficiency of the journal's peer review process.

Now in its 12th year, *JREHD* continues to serve as a crucial platform for rigorous, interdisciplinary scholarship that identifies, measures, and addresses racial and ethnic health disparities.

2025 YEAR IN REVIEW

Leadership growth defined 2025. The Institute expanded its role in health equity, research engagement, student mentorship, and national programming, while the Board of Directors reached full capacity at 17 members, strengthening connections across NMA leadership, SNMA leadership, academic medicine, surgery, health policy, and community-based research.

National convening remained central to the Institute's visibility. At the 2025 NMA Convention in Chicago, the Institute hosted the Cobb Lectureship and Symposium, Artificial Intelligence: Code, Context, Care: AI at the Crossroads of Healthcare, Research and Workforce Development, in partnership with the Cato T. Laurencin Institute for Regenerative Engineering at the University of Connecticut (UConn) and sponsored by the Robert Wood Johnson Foundation (RWJF). The symposium brought together national experts to examine AI in health care, research, and workforce development and was livestreamed to broaden access.

Partnerships also continued to deepen. The Institute expanded its collaboration with the International Medical Exchange to explore AI-driven strategies for improving health care delivery and public health outcomes in Africa, the United States, and other underserved communities. This work included a hybrid convening with academic leaders, subject matter experts, institutional directors, and participants from Africa, Canada, and the Caribbean.

Student mentorship remained a core priority.

Through the International Myeloma Foundation's Myeloma Scholars and Mentorship Program, the W. Montague Cobb Institute and SNMA identified 12 student scholars, who presented research posters, met with mentors, and shared abstracts during the Cobb Scholars Convening. The Institute also launched a two-year financial literacy program in partnership with Prudential and continued support for the Dr. Wilbert C. Jordan Research Fund.

Research engagement expanded through NMA Project IMPACT 2.0, which supported educational content, symposium planning, annual report development, community engagement, and Steering Committee leadership. Cobb also created and beta tested an NMA member survey to better understand physicians' experiences, interests, and engagement in clinical trials and clinical research.

Public education remained another important pillar of the Institute's work. The monthly webinar series with BlackDoctor.org continued to feature subject matter experts and patient advocates on topics including vaccine hesitancy, FDA regulations, maternal health, and clinical trial diversification. The *Cobb & Company* podcast also highlighted thought leaders and industry leaders aligned with the mission of the W. Montague Cobb Institute and the NMA.

Community and academic partnerships further extended the Institute's reach. Through collaboration with Howard University Hospital and the Howard University College of Medicine Department of Surgery, the Institute held its Third Annual W. Montague Cobb Health Disparities Symposium, which highlighted artificial intelligence, chronic disease, and health disparities.

With a distinguished career, Dr. Mikhael recently led ASCO guidelines for multiple myeloma and served as a hematologist at Mayo Clinic Arizona. Recognized for his educational contributions, he was named one of the Top 100 Doctors in the United States and received induction into the Mayo Clinic Resident and Fellow Association Hall of Fame. Trained in Ottawa, Canada, Dr. Mikhael specializes in plasma cell disorders, particularly multiple myeloma, and leads numerous clinical trials in this field. He has authored over 150 peer-reviewed articles and is a member of the IMF's International Myeloma Working Group and the editorial board of the Journal of Clinical Oncology. Dr. Mikhael leads the IMF's M-Power Project, focused on improving myeloma care for African Americans, and advocates for increased access to myeloma therapies globally.

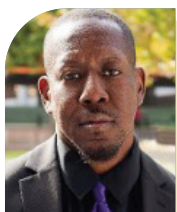
